Decision on changed accreditation

Decision

Swedish Board for Accreditation and Conformity Assessment (Swedac) amends its decision dated the decision 2019-02-08 in case 2017/2643 in such a way that the applicable provisions for the accreditation set out in Appendix 1 are amended for Outokumpu Stainless AB (registration number 556001-8748) accredited also as testing laboratory for:

- ASTM A370, utg 18
- ASTM E10, utg 18
- ASTM E112, utg 13
- SS-EN ISO 6892-2:2018, utg 2

Swedac has performed an assessment of Outokumpu Stainless AB against the requirements SS-EN ISO/IEC 17025:2018 and considers that the requirements are fulfilled.

The new scope of accreditation is specified by the marked changes in appendix 2.

The accreditation is valid until further notice.
